1 Institutionality

The Statute and the Maintenance and Development Agreement of BIREME continues to coexist as the institutional frameworks of the Latin American and Caribbean Center on Health Sciences Information (BIREME), Pan American Health Organization (PAHO)/World Health Organization (WHO) Specialized Center, part of the Area of Knowledge Management and Communications (KMC), since the new institutional framework of the Center is in process of implementation in the 2012-2013 biennium.

The Maintenance and Development Agreement of BIREME is valid until December 31st, 2013, in coordination with its signatories, PAHO/WHO, and the institutions representatives of the Government of Brazil, the Ministry of Health, Ministry of Education, the Health Secretariat of the State of São Paulo (SES-SP), and the Federal University of São Paulo (UNIFESP) as the Agreement of Headquarters of BIREME in Brazil and the subsequent Agreements are being established between the parties.

The efforts undertaken in the maintenance and development of the institutional framework of BIREME are characterized by uninterrupted cooperation between PAHO and the Government of Brazil in the last four decades, in order to ensure the maintenance, development and institutional strengthening of the Center.

Cooperation between PAHO and the signatories of Brazil aiming the maintenance and development of BIREME, which dates from the foundation of BIREME in 1967, constitutes an example of south-south cooperation with large impact on the democratization of the access and publication of scientific information for the great majority of the countries of Latin America and the Caribbean (LA&C) and indirectly for the developing countries of Africa and of Asia¹.

BIREME as an International Organization and Reference Center in scientific information and communication has ensured to the countries of the Region the continuity of the governance, development, operation, and innovation of products, services, events, systems, methodologies, and technologies of scientific and technical information following the international state of the art. Thus, BIREME contributes systematically and efficiently to sustain, strengthen, and increase the capacities and infrastructures of scientific information and communication in Brazil and in the Region.

The progress of BIREME's operation is made evident by the fact that the technical cooperation by means of the Virtual Health Library (VHL) and Associated Networks is present in 30 (thirty) countries and it includes over 2000 (two thousand) institutions. The Annex document has information on the technical cooperation of BIREME via VHL and its regional strategic network of institutions.

The VHL is a component of the Strategy and Plan of Action on Knowledge Management and Communications approved in 2012, at the 28th Pan American Sanitary Conference, as well as of the Strategy and Plan of Action on eHealth approved in 2011, in the 51st Session of the Directing Council of the Organization.

Among the main characteristics of BIREME's actions, it is remarkable, on the one hand, the cooperative work through the networks of individuals and institutions in information management and knowledge sharing. On the other hand, it points out the pursuit of the international state of the art in the development, adoption, and adaptation of indexing and retrieving methodologies and technologies for scientific and technical information, according to the economic, cultural and of infrastructure conditions of the Region.

No other developing region relies, in its public health systems, with an entity similar to BIREME, what can explain the greater development and dynamism of information and scientific communication in health in the Region. BIREME historically contributes to the insertion of the scientific output of LA&C in the global flow of scientific information and in overcoming the access barriers to scientific information, including connectivity, language, culture, and financial resources.

The Statute of BIREME approved on 2009 in the 49th Session of the Directing Council of PAHO (CD49.R6), then valid from January 1st ,2010, represents a historical recognition of PAHO country members on its importance as a specialized center oriented to the democratization of the access to information, knowledge and scientific evidence, as an essential condition for the advance of the equity in health based on the continuous increase of the capacities of research, education and health care systems.

Regarding the organizational management of the Center, Adalberto O. Tardelli was selected by international selection process and nominated Director of BIREME starting in July 1st, 2012. Tardelli, an international PAHO employee, held the post of Information Advisor of Information and was the Health Systems and Manager of Administration of Sources of Information in BIREME.

Still regarding the management of BIREME, PAHO/WHO Office in Brazil (PWR BRA), in coordination with the corresponding regional areas, the Area KMC and the Area of Health Surveillance and Disease Prevention and Control (HSD), assumed the leadership in the harmonization of the institutional managerial processes in all its dimensions, regulating work sharing and cooperation between PAHO Offices and Centers in Brazil. In this regard, a script was also elaborated for the integration and institutional harmonization of the Centers in the managerial, technical, and administrative areas. All the cooperation activities scheduled with Brazil have been analyzed and the joint implementation with PWR BRA was designed, based on what has been established on the provisions of the country's cooperation strategy.

1.1 CRICS9 and VHL6

The Regional Congress on Health Sciences Information (CRICS), one of the main events coordinated by BIREME, had its 9th edition accomplished in Washington, DC, USA, at PAHO/WHO headquarters, from October 22nd to 24th 2012, also in context with the celebrations of the 110th Anniversary of the Organization.

The organization of CRICS9 (http://www.crics9.org) was carried out by BIREME in coordination with the Area KMC of PAHO, jointly with the supporting institutions such as the National Library of Medicine (NLM) of the United States, the American Public Health Association (APHA) as well as governmental and nongovernmental institutions of countries, also from outside the Region, that made possible the participation of its collaborators as lecturers, panelists and assistants.

With central topic "eHealth: reaching universal access to health", the scientific program of CRICS9 brought together 85 panelists and 20 moderators that presented and shared their experiences and knowledge in 5 plenary sessions and 15 panels to an audience of approximately 400 people from 41 countries. CRICS9 still offered six workshops and presentation space for 87 electronic posters from 17 countries.

CRICS9's program² promoted an open forum on Public Health relevant topics in the Americas considering five themes:

- 1) Integration of scientific evidence with health decisions;
- 2) Sharing of experiences and good practices in Health in the Americas:
- 3) Public policies and strategic partnerships on eHealth;
- 4) Use of information technologies in search of solutions to health problems, particularly of the vulnerable populations; and
- Development of capacities, especially for the health services and in response to emergencies and disasters.

During the Congress, PAHO reaffirmed its commitment to the Member States in the establishment of national and regional policies that promote the free, equitable and open

access to information and scientific evidence; the education of health workers to enable them to operate in the information society; the dissemination of critical information on health for the general public, that allows them to make favorable decisions on their wellbeing; and the strengthening of BIREME and the VHL as main tool for an improved governance of the scientific and technical information in health sciences.

Preceding CRICS9, the 6th Regional Coordination Meeting of the VHL (VHL6) took place on October 20th -21st, 2012, also in Washington, DC, USA. The Regional Coordination Meeting of the VHL is the most important live forum of the cooperative network of institutions producers, intermediaries, and users of scientific and technical information in the Virtual Health Library.

VHL6 brought together 220 representatives of the VHL and Associated Networks with the main objective of promoting an extensive discussion on the development of the VHL oriented to the objectives of the Strategies and Plan of Action on eHealth (2012-2017) and Knowledge Management and Communications for Latin America and the Caribbean as well as to discuss the recommendations of the VHL Meetings 2011³, and the aspects of scientific health information as a public regional good.

In order to anticipate the debate and the discussions of the VHL Network on the main challenges for the development of the VHL, and bring to VHL6 recommendations for validation and approval by the network participants, three Working Groups were created. Eighteen virtual meetings took place, which relied with the network's broad participation. The recommendations of the VHL6 Working Groups⁴ should subsidize the working plan of the VHL Network for 2013 and 2014, to be considered in BIREME's work plan with the support of the BIREME's International Community of Practice (CoP-BIREME).

2 New Institutional Framework

Since 2009 BIREME benefits from the important institutional progress expressed by the approval of the new institutional governance, operation and financing framework, in response to the growing breadth, density and complexity of the functions performed by BIREME in national, regional and global levels⁵.

The new institutional framework replaces the foregoing established by the Maintenance and Development Agreement of BIREME signed by PAHO and the Government of Brazil, through the Ministry of Health, the Ministry of Education, the Health Secretariat of the State of São Paulo (SES-SP) and UNIFESP, in which campus BIREME is physically located. Since 1967, the Agreement is being renewed to every four or five years. The current version is being extended in order to serve the transition period for the implementation of the new institutional framework.

The main document that defines the new institutional framework is the Statute of BIREME, approved in the 49th PAHO Directing Council, which took place from September 28th to October 2nd, 2009. The approval of the new statute is the result of a large process of consultation led by PAHO with its Member States and particularly with Brazil under the leadership of the Ministry of Health.

The resolution of the 49th PAHO Directing Council (CD49 .R6) established the structure of the new legal framework formed by the Statute of BIREME and two complementary legal instruments: 1) the Headquarters Agreement of BIREME in Brazil, to be established between PAHO and Government of Brazil; and 2) the Installations and Operation Agreement of BIREME in UNIFESP, to be established between PAHO, the Government of Brazil and UNIFESP itself.

The Statute of BIREME also determines the new structure of governance of BIREME, with the following composition:

- A) BIREME Members defined in the categories: a) Member States: all Member States, Participating States, and PAHO Associated Members; b) Participating States: the WHO Member States besides those that are PAHO Members; and c) Participating Organizations: public international organizations with specific qualification related to information and scientific and technical communication. The participation of new members shall be defined by PAHO;
- **B)** Advisory committee: formed by PAHO and the Government of Brazil as permanent members and by five of PAHO Member States as non-permanent members. At the 49th PAHO Directing Council (CD49.R6) Argentina, Chile, and the Dominican Republic were nominated, with a three years mandate (2010-2012) and Mexico and Jamaica for a two years mandate (2010-2011). At the 51th PAHO Directing Council (CD51.R2) Bolivia and Suriname were named for a three years mandate (2012-2014). At the 28th PAHO Pan American Sanitary Conference (CSP 28.R5) Cuba, Ecuador, and Puerto Rico were nominated for a three years mandate (2013-2015). The role of this Committee is to make recommendations to the Director of PAHO on the programming functions, the working plan and the financing of BIREME. Three Sessions of the Committee occurred in compliance with the implementation of the new institutional framework of BIREME, following Resolution 5 of the 49th PAHO/WHO Directing Council (CD49.R5):
- **C)** Scientific Committee: permanent organ of BIREME formed by scientific information specialists appointed by the Advisory Committee of BIREME. Its function is helping to maintain and improve BIREME's capacity to follow the development of methodologies, technologies, products, services, and events that characterize the national and international systems of information and scientific communication and the challenges for their contextualization in the LA&C. The process of indication of its members by the national authorities, appraisal, and nomination of members of the Scientific Committee was concluded in December 5th 2012, in the III Session of the Advisory Committee. The four members named were indicated by Canada, Honduras, Trinidad and Tobago and Brazil and, a fifth member from the National Library of Medicine of United States was indicated by the Director of PAHO. The meeting for installation of the Committee is programmed for July 2013; and

D) Secretariat: permanent organ of BIREME, formed by the Director and by the technical and administrative teams of the Center. It is responsible for the management and execution of the programming functions of BIREME's biennial work plan 2012-2013 that was developed in coordination with the Area KMC of PAHO being characterized as subplan of work of the Area KMC.

2.1 Situation of implementation

The new Statute of BIREME is effective since January 2010, coexisting with the Maintenance and Development Agreement of BIREME, until the new institutional framework of the Center is totally implemented. When the Headquarters Agreement is signed by the parties, the Maintenance and Development Agreement will be extinguished.

The full effectiveness of the new institutional framework of BIREME demands the following implementations:

- Implementation of the Headquarters Agreement of BIREME in Brazil between PAHO and Government of Brazil, represented by the Ministry of Health. This process is ongoing, and several meetings with the Ministry of Health are being carried out since 2010. The Headquarters Agreement of BIREME, being negotiated, foresees the establishment of a National Advisory Committee composed by members indicated by PAHO and the Brazilian Government;
- Implementation of the Installations Agreement of BIREME in the Campus of UNIFESP through dialogues among PAHO, the Ministry of Health and UNIFESP. This process is also ongoing since 2010. The Installations Agreement of BIREME in the Campus of UNIFESP, being negotiated, foresees the establishment of a specific technical cooperation project between BIREME and UNIFESP;
- Implementation of the Scientific Committee of BIREME with an agenda centered on the analysis and recommendations on BIREME working plan, its products, services, methodologies, and scientific information technologies; and
- Based on the recommendations of the Advisory Committee of BIREME, definition by common consent with PAHO and the Ministry of Health on the regular year-financial contributions to BIREME.

2.2 BIREME financial structure


The establishment of a stable and balanced structure for financing BIREME was one of the main motivations for the BIREME's institutional reform. The Statute of BIREME foresees that this structure of financing is analyzed and recommended by the Advisory Committee of BIREME, also recommending the financial contributions from Brazil and from PAHO, and from the participating members of BIREME.


In recent years, BIREME and its national signatories discussed the need for balancing the regular contributions with the non-regular contributions originated from projects, agreements and delivery of services. According to this model, PAHO and the Ministry of Health should contribute together with 50% of BIREME's annual budget. As new participating members join BIREME, the sources of contribution as regular resources shall increase. At the same time, BIREME should be able to mobilize the additional resources through projects, agreements, grants, and delivery of services.

Considering that the average budget of BIREME in recent years was around US\$ 5 million / year, the regular equivalent contributions from the Ministry of Health and PAHO would be about for US\$ 1.25 million/institution/year. The other 2.5 million should be mobilized by BIREME.

In 2012, the contribution from the Government of Brazil, from the Ministry of Health was of US\$ 1.9 Million, a contribution formalized in mid-October, via the 20th Additive Term to the Maintenance and Development Agreement of BIREME. The 2013 contribution from the Government of Brazil is being negotiated.

The charts below show the evolution of BIREME budget in absolute values and in percentage considering the Maintenance and Development Resources (in blue) and Grants and Projects Resources (in red).

A.1 Overview of VHL Network

The VHL (Virtual Health Library) is the result from technical cooperation on health sciences information delivered by BIREME/PAHO/WHO since its foundation in 1967. The VHL model of information management and knowledge sharing through the Internet as a platform for production of sources and flow of scientific and technical information was launched in 1998 at the IV Regional Congress on Health Sciences Information (CRICS4), by means of the Declaration of San José "Towards the Virtual Health Library".

The VHL is the strategy that PAHO/WHO leads through BIREME and their networks for the development and strengthening of national and regional capacities of scientific and technical information in health. The ongoing goal of VHL is to promote equity of access and publication of information, knowledge and scientific evidence on health.

This proposal receives special relevance due to the recognition of the VHL as part of the strategy for eHealth by the area of Knowledge Management and Communications from the Pan American Health Organization (KMC/PAHO/WHO) and approved at the Meeting of the PAHO Governing Board in 2011. The VHL Network is coordinated by BIREME and operated in a decentralized way by national, regional and thematic networks. Each of these networks converge its operation on an instance of the VHL, with a portal that follows common methodologies for storing and publishing of content. Thus, besides the Regional VHL instance operated by BIREME, there are instances of VHL in 30 countries, with a total of 110 regional, national, thematic and institutional active instances.




Figure 1 - VHL instances distribution in June/2013

Figure 1 shows the distribution of VHL instances according to region and includes regional thematic instances.

A.1.1 VHL Regional

In the first semester of 2013, 5.8 million visits to the VHL Regional Portal and the VHL Search Service were registered, which resulted in 18.6 million interactions. In absolute numbers, most of them (5.4 million - 92% of the visits) were originated from users from Latin America and the Caribbean (LA&C).

A.2 Initiatives at Institutional, National and International levels

A.2.1 Institutional

A.2.1.1 World Health Organization (WHO)

Evidence-Informed Policy Network - EVIPNet

EVIPNet - Evidence-Informed Policy Network is an initiative that arises from the announcement of WHO, to establish mechanisms to facilitate the use of scientific evidence in the formulation and implementation of health policies. To meet this purpose, EVIPNet provides the methodology to Network participating countries, which promotes among decision makers and health researchers the so-called knowledge translation.

Since 2005, BIREME/PAHO/WHO has collaborated with WHO and PAHO to develop technical cooperation activities to information management for EVIPNet, both in the availability of the content on the Portal of Evidence of the VHL to meet the needs of the network, and in the management of EVIPNet Portal and developing policy brief - summary of evidence for informed policy.

Global Health Library (GHL)

The Global Health Library (GHL) was publicly launched in September 2005, during the 9th World Congress on Health Information and Libraries (ICML9) and 7th Regional Congress on Health Sciences Information (CRICS7) performed simultaneously in Salvador, Bahia, Brazil. The GHL aims to organize, index, interrelate and provide international, national and local information sources, including sources available in the libraries of regional offices of WHO. Thus, health has a comprehensive Internet-accessible library available to all.

TroplKA.net - Tropical Diseases Research to foster Innovation and Knowledge Application

The TropIKA.net - Tropical Diseases Research to Foster Innovation and Knowledge Application project is a program of the TDR/WHO, developed in partnership with BIREME/PAHO/WHO, Fred Toth Associates, Dynamic Diagrams, HINARI, National Library of Medicine (NLM) and Public Library of Science (PLoS).

The platform was launched during the Global Forum for Health Research - Forum 11, on October 30th 2007 - http://www.eventos.bvsalud.org/tropikalaunch/ and since then, BIREME/PAHO/WHO hosts, operates and collaborates with the development of the TropIKA technology platform, including the role of portal webmaster.

ePORTUGUÊSe – Network of Health knowledge and information sources for Portuguese speaking countries

The ePORTUGUÊSe initiative is led by WHO and has as one of its main lines of action to adopt and implement the VHL in the eight Portuguese-speaking countries in the world: Angola, Brazil, Cape Verde, Guinea-Bissau, Mozambique, Portugal, Sao Tome and Principe and East Timor. The ePORTUGUÊSe Network has the formal support of the Community of Portuguese Language Countries (CPLP), and maintains the operation of its global portal and collections and national portals in eight countries. The portal was launched in May 2009.

A.2.1.2 Pan American Health Organization (PAHO)

Annotated Medicines Hyper Lists (MedList)

MedList is a technical cooperation project between BIREME/PAHO/WHO and the unit HSS/MT - Drugs and Technologies in Health – from PAHO headquarters in Washington, DC, which aims to manage and publish Drug Lists. The MedList is a component of the Regional Platform for Innovation and Access to Health Technologies (PRAIS - http://www.paho.org/prais), coordinated by the staff of HSS/MT and whose launch took place on May 7th, 2012.

A.2.2 National

A.2.2.1 Ministry of Health

There are a lot of technical cooperation projects between BIREME and the Ministry of Health of Brazil, considering several technical cooperation agreements between PAHO and the Brazilian government. Besides the development of the national VHL (http://brasil.bvs.br/) and various thematic instances, such as Public Health (http://saudepublica.bvs.br), Infectious Diseases (http://www.bvsdip.icict.fiocruz.br), Primary Health Care (http://aps.bvs.br) and others (see more - http://bit.ly/brazil-vhl-instances), BIREME has promoted, in the context of this technical cooperation, some innovations for the VHL, such as mobile interface and web accessibility in accordance to W3C. The first VHL instance that reached the triple A (AAA) level of accessibility was the Institutional VHL of the Ministry of Health of Brazil (http://bvs.saude.gov.br/).

EVIPNet Brazil

The development of EVIPNet in Brazil, started in 2008, has been led by the *Departamento de Ciência and Tecnologia* from *Secretaria de Ciência, Tecnologia and Insumos em Saúde* (SCTIE/DECIT) of the Ministry of Health, with the cooperation of BIREME/PAHO/WHO for activities of information management and knowledge transfer directly related to its implementation

plan. In 2009 and 2010, important results have been achieved, especially for the production of the first synthesis of evidence EVIPNet Brazil on reduction of perinatal mortality in the North and Northeast of Brazil, with options for intervention in primary care. http://sintese.evipnet.net.

VCPH Project

The VCPH projects as a convergence space for action of individuals and institutions networks oriented to the development of individual skills and institutional capacities in Public Health in Latin America and the Caribbean. Its focal point is the educational institutions of the region, in order to strengthen the strategies and mechanisms to bring the knowledge to the practice in the area of public health. The VCPH is promoted and coordinated by PAHO and its implementation and operation are decentralized in the countries. Each country has a leading institution that represents it in the VCPH network, while each country, depending on their ability, can shape a national network of institutions integrated to VCPH.

Registry of Clinical Trials Platform in the Brazilian context (REBRAC) and Latin American (RECLAC)

BIREME/PAHO/WHO has contributed since mid-2007 in the discussions on clinical trials registries in Latin America and the Caribbean (LA&C).

REBRAC - the Brazilian Registry of Clinical Trials (http://www.ensaiosclinicos.gov.br/), operated by ICICT/Fiocruz, is the first clinical trials registry in Portuguese language in accordance with ICTRP/WHO criteria. REBRAC has been recognized as a WHO primary registry since March 2011.

BIREME is responsible of the technological platform development – OpenTrials – (http://trac.reddes.bvsalud.org/projects/clinical-trials) used by REBEC, which is a free and open source software (FOSS) available for download, use and customization by any country or region. OpenTrials platform is a product of a technical cooperation project involving Brazilian Government (Ministry of Health and Fiocruz), PWR/Brazil, HSS/PAHO and BIREME.

A.2.2.2 Secretary of Health of State of São Paulo

The Secretary of Health of the State of São Paulo (SES-SP acronym in Portuguese) is a member of BIREME National Advisory Committee and since 2006 has been developing technical cooperation projects on knowledge and information management with BIREME. The SES-SP adopted the Virtual Health Library (VHL) model to develop its Information and Knowledge Network Portal (http://ses.sp.bvs.br), which provides access to the scientific and technical production from its thirteen research institutes. Besides this portal, the SES-SP also operates, with BIREME

support, a Portal of Journals (http://periodicos.ses.sp.bvs.br), which provides full text access to the scientific and technical articles published by five research institutes.

A.2.2.3 Fundação Oswaldo Cruz (Fiocruz)

Development of methodologies and systems for electronic publishing of scientific books from university publishers (SciELO Books)

The methodologies and technological platform of the SciELO Books project were developed by BIREME/PAHO/WHO, in cooperation with university publishers from Fiocruz, UNESP (*Universidade Estadual Paulista*) and Ufba (Federal University of Bahia), with the goal of creating and develop capacities and conditions for the establishment and consortium operation of a network of online collections of scientific books.

PROQUALIS

The Collaborating Centre for Quality of Care and Patient Safety (PROQUALIS) is coordinated by the *Instituto de Comunicação and Informação Científica and Tecnológica em Saúde* [Institute of Communication and Scientific and Technological information in Health] (ICICT/Fiocruz). PROQUALIS aims to identify, organize and disseminate the health information related to quality of care and patient safety.

BIREME cooperated with ICICT to design, develop and operate the PROQUALIS web portal (www.proqualis.net), giving access for this health information organized in different areas, such as patient safety (adverse events, medicines, Brazilian experiences and global initiatives) and clinical information (safe births, asthma, diabetes mellitus, chronic obstructive pulmonary disease, arterial hypertension and heart failure).

- 1. **Maintenance –** maintenance and sustainability of the Center;
- 2. **Exchange –** exchange of products and services;
- 3. **Technical Cooperation** technical cooperation projects;
- 4. International Committees international committees and systems;
- 5. **National Committees –** national committees and systems;
- 6. Security security management systems of the United Nations; and

7. **Others –** other types of activity or working relationships.
