#### Third Session of the Scientific Committee Latin American and Caribbean Center on Health Sciences Information (BIREME)

#### BIREME/PAHO/WHO Evidence and Intelligence for Action in Health (EIH)

The third session of the Scientific Committee of the Latin American and Caribbean Center on Health Sciences Information (BIREME/PAHO/WHO) was held at BIREME, in São Paulo, Brazil, on December 7 and 8, 2017, in compliance with the Resolution 5 of the 49<sup>th</sup> PAHO/WHO Directing Council (CD49.R5), which approved BIREME's Statute, effective as of 2010, which defines its new institutional framework.

The current members of the Scientific Committee were appointed during the sixth Session of BIREME Advisory Committee on February 2, 2017 for a three-year term (2017-2019). They are specialists from six (6) PAHO/WHO Member States: Brazil, Colombia, Costa Rica, Cuba, Jamaica and Mexico.

# FINAL REPORT

São Paulo (SP), December 7 and 8, 2017

### FINAL REPORT

#### **Session Opening**

- 1) On December 7 and 8, 2017, at BIREME, in the city of São Paulo, Brazil, the Third Session of the Scientific Committee of the Center took place, which serves advisory functions before the Advisory Committee and the Director of PAHO/WHO. The Session started with welcome words by Diego González Machín, Director of BIREME and Secretary *ex officio* of the Scientific Committee, who gave the floor to Francisco Becerra, Deputy Director of PAHO/WHO and Interim Director of the Department of Knowledge Management, Bioethics and Research (KBR), who mentioned the importance to rely on a Specialized Center on Scientific and Technical Information for the Region, that facilitates access to quality information, and promotes visibility of scientific output of Latin America and the Caribbean. He also recognized the support of the members of BIREME Governance Committees who also represent the Organization's Member States.
- 2) The presence and participation of specialists of the Scientific Committee was appreciated and the importance of conducting the meeting in the context of the development of the Center was highlighted. The members of the Committee were introduced and the work was initiated.
- 3) In order to contribute effectively to the discussions and the effective contribution of recommendations by the members and participants, the Session was attended by Mauricio Bustamante, PAHO/WHO Temporary Consultant, with experience in health services management.

### PRESENTATIONS

- 4) On December 7, 2017. The presentation "BIREME TODAY" Products and services of BIREME as PAHO/WHO Technical Cooperation by Diego Gonzalez Machín, Secretary ex-officio who was supported by the management, administration and technical team of BIREME highlighted the main elements that distinguish the Center, as well as its technical cooperation program, projects, products and services available to the countries of the Region (and elsewhere) at local, national, regional and global levels. He also emphasized the historical importance of BIREME in the Region of the Americas as a Specialized Center of the Organization, consolidated in its 50 years of existence, celebrated in 2017, also by the number of institutions (more than two thousand) that operate in network for the access and use of scientific and technical information in health. It was informed that institutionally, from January/18 BIREME would be part of the Evidence and Intelligence for Action in Health (EIH) Department, since KBR (Knowledge Management Bioethics and Research) was dismembered.
- 5) On December 8, 2017. The presentation "BIREME Needs and Benefits of Health Information for Decision Making - A Late Look from a Manager in the Operation of

*Health Services and in the Territory*" by Mr. Mauricio Bustamante, PAHO/WHO Temporary Adviser with experience in the management of Health Services, socialized a vision of BIREME's potential and how the Center could strengthen its alliances with the decision makers in the Region by weighing the needs and benefits of health information for decision making.

- 6) The discussions and recommendations were addressed to the following topics:
  - a. What can BIREME do that nobody else does, what is its added value? How to expand work at the country level or south-south cooperation?
  - b. Potentialities of BIREME's role in PAHO Strategic Plan and its role in achieving the SDG: How to link with the Sustainable Health Agenda of the Americas and achieving the SDG?

#### Matters concerning Regulation

7) On December 8, 2017, the following specialists were chosen to constitute the Board of Directors of BIREME Scientific Committee in its Third Session.:

Rapporteur:	Roberto Carlos Pacheco (Brazil)

#### **Comments and Recommendations**

- 8) The discussions, comments and recommendations issued, facilitated by the President of the Session and by the Secretary *ex officio* were directed towards the continuous development and strengthening of BIREME, expressed in proposals for effective dissemination of its projects, products and services in the countries of the Region besides the need to venture into strategic issues.
- 9) It is important to follow the recommendations in the two topics, which were widely discussed and agreed among the members of the Scientific Committee:

**First** *TOPIC:* What can BIREME do that nobody else does, what is its added value? How to expand work at the country level or south-south cooperation?

Efrén Carlos Oropeza Abúndez, Scientific Communication. Mexico Recognize the identity of BIREME and define actions to disseminate the Center's work in the countries; Support and promote open access policies through LILACS, taking into account innumerable international recent initiatives in this regard; and Develop products for the analysis of scientific output for institutions and/or countries through impact metrics.

Ileana Regla Alfonso Sanchez, Information Management. Cuba Strengthen VHL and LILACS as open access instruments to democratize access to health information.

Roberto Carlos Pacheco, Knowledge Engineering and Information Systems. Brazil Undertake alliances, strengthen governance and collaborative production in the development of projects, products and services.

Mario Guillermo Tristán Lopez, Scientific Research. Costa Rica Participate in open science initiatives and scientific dissemination aimed at the population to make viable citizen commitment.

Jaider Ochoa Gutiérrez, Education and Knowledge Management. Colombia Support open science practices (open access, open data, metrics and alternative metrics available openly) and show positioning in this sense; Develop observatories - with the appropriate information architecture - for consultation by decision makers.

**Second** TOPIC: Potentialities of BIREME's role in PAHO Strategic Plan and its role in achieving the SDG: How to link with the Sustainable Health Agenda of the Americas and achievement of the SDG?

Georgiana Marie Gordon-Strachan, Scientific Research. Jamaica Support the 2030 Agenda through the implementation of the SDGs, given that the information is transversal; and Map what countries are doing regarding the SDG.

Mario Guillermo Tristan Lopez, Scientific Research. Costa Rica Promote the exchange of information between countries on successful projects and experiences; and Consider the judicialization in health considering the individual and collective rights.

Roberto Carlos Pacheco, Knowledge Engineering and Information Systems. Brazil Evaluate public policies with trends towards the implementation of SDGs 6 and 7; and Analyze supply and demand to create multisectoral projects, having health defined and perceived as public good (*commons*).

Jaider Ochoa Gutierrez, Education and Knowledge Management. Colombia Keep BIREME strengthened as a reference in supporting scientific communication. Ileana Regla Alfonso Sanchez, Information Management. Cuba Evaluate potentials, actions and areas of action with focus on training.

Efrén Carlos Oropeza Abúndez, Scientific Communication. Mexico Consider the experience of some countries on "the health in all policies" initiative.

The delegates reiterated their support for the continued development and strengthening of BIREME as a regional reference institution in scientific and technical health information with the objective of strengthening the democratization of information in the countries of Latin America and the Caribbean.

### **Other topics**

- 10) The members of the Committee and the participants reached a consensus on the recommendations already included in this final report, which will be sent for consideration by the Director of PAHO / WHO.
- 11) The presence of the members of the Committee was acknowledged, highlighting the discussions held and the results achieved in the meeting, as well as the BIREME team for their performance in the Center on scientific health information and especially in holding the III Session of the Scientific Committee.

#### **Session Closure**

After the exchange of recognitions and expressions of courtesy, the main objectives reached were pointed out towards the new institutional positioning of the Center.

IN FAITH WHEREOF, the Sixth Session of the Advisory Committee of the Latin American and Caribbean Center for Information in Health Sciences (BIREME) was ended, the President of the Meeting and the specialist delegate in information management, of Cuba and the Director, of BIREME and Secretary *ex officio*, signed this final report in the original language, Spanish.

It took place in São Paulo, Brazil, on the seventh and eighth day of the month of December of the year two thousand and seventeen.

The original signed document will be deposited in the archives of the Pan American Sanitary Bureau.
